Klaus-Dieter Schürmann was born in Recklinghausen in 1963. He graduated in Business Administration from the University of Cologne (Dipl. Kfm.) and earned his Master of Business Administration degree as a Fulbright Commission scholar at the University of Virginia (Darden School).

Having started his career at Volkswagen AG in the Group Product Planning area in 1990, he worked as an Assistant to a Board Member from 1992 to 1994.

In 1995 he was appointed President and CEO of Volkswagen Credit, Inc. in the USA and Volkswagen Credit Canada, Inc., directing both companies until 2000. In this position, he was also on the Board of Directors at Volkswagen America, Inc. and Volkswagen Canada, Inc.

In 2000 Schürmann was appointed general representative of Volkswagen Financial Services AG and Volkswagen Bank GmbH in Braunschweig. From 2003 he worked as a Board Member of Volkswagen Financial Services AG as well as in the senior management at Volkswagen Bank GmbH and Volkswagen Insurance Services GmbH.

In 2006 Mr. Schürmann became Management Spokesperson at Volkswagen Bank GmbH. In 2008 Schürmann was appointed Board Member for Finance and IT at Volkswagen Commercial Vehicles.
