Dieter Seemann was born on 25 August 1957 in Hildesheim, Germany.

After finishing high school in 1979, he was trained as a car mechanic. He then studied and graduated with a diploma in Industrial Engineering.

Seemann started his career at Volkswagen AG in 1985 in the Purchasing department for engine launches.

Between 1989 and 1992 he was the Head of Purchasing at Shanghai Volkswagen in China. Seemann subsequently returned to Wolfsburg where he worked in the purchasing of engines and vehicles.

From 1993, he spent three years in the purchasing of plastic components and externally procured car bodies.

In 1996 Dieter Seemann took over the leadership of Forward/Global Sourcing at Volkswagen de México, where he became Vice President of purchasing in 1999.

Between 2001 and 2005, he led the Purchasing department in Wolfsburg for new product launches for both the Volkswagen brand and Group. He then transferred to Shanghai Volkswagen, China, to become Deputy Managing Director & Commercial Executive Director.

In 2009 Seemann became CFO of SEAT in Martorell, Spain, moving on to become the Board Member for Purchasing there in April 2010.
