Bohdan Wojnar was born in Třinec in 1960.

He graduated from the University of Chemistry and Technology in Prague (Economics and Management programme) and in 1993 he completed his international studies at European Business School, also in Prague.

After finishing his university studies he started working for Kaučuk in Kralupy nad Vltavou in 1983. In 1985 he joined ŠKODA AUTO where he held various positions in the financial sector. In 1996 he became head of ŠKODA AUTO Controlling department.

From 2006 Bohdan Wojnar was a member of the Board of Management for Finance in Volkswagen Slovakia, a.s., and from 2008 he was a member of the Board of Management for Finance as well as Human Resources in Volkswagen Slovakia, a.s. From 2009 to 2010 he was a member of the company's Board of Management for Human Resources.
