Holger Peters was born in Beckum, Germany in 1968.

He graduated in European Business Administration in Berlin and Cambridge (UK) in July 1996.

In August 1996, Peters began his career in the automotive industry at Dr. Ing. h.c. F. Porsche AG as an affiliate controlling specialist. In 2000, he became Head of Finance, Accounting and Treasury at AFN Ltd./ Porsche Retail Group Ltd. in London.

In June 2003, Holger Peters was appointed Head of Affiliate Controlling at Dr. Ing. h.c. F. Porsche AG in Stuttgart, where he oversaw Affiliate and Group controlling.

At the end of 2009, Holger Peters was appointed Vice President of Controlling at Dr. Ing. h.c. F. Porsche AG. In this role, he was also Deputy to the Executive Board Member for Finance and IT and authorised signatory of Dr. Ing. h.c.F. Porsche AG and Porsche Holding Stuttgart GmbH.

In September 2017, Holger Peters took on the role of Managing Director at Porsche Financial Services GmbH before becoming Group CEO and Spokesperson of the Board of Management in August 2018.

In January 2022, Peters transferred to Volkswagen AG in Wolfsburg as Head of the Europcar Transformation Office. In this role, he oversaw the acquisition of Europcar Mobility Group S.A. before being appointed Chief Representative of Volkswagen Bank GmbH in February 2023.

Since June 2022, he has also held the position of Supervisory Board Chairman of the Europcar Mobility Group S.A. and Green Mobility Holding S.A.

In June 2023, Holger Peters was appointed Member of the Board of Management for Finance, IT and Legal Affairs at Škoda Auto a.s. in Mlada Boleslav.
